



COMMERCIAL LIABILITY

Enhancement Endorsement

PROTECT YOUR PEOPLE, PROPERTY, AND PROFITS

Voluntary Property Damage Coverage—Provides up to \$2,500 per occurrence/\$5,000 per policy period property damage coverage for unintentional damage to property of others in your possession taking place away from your premises and resulting from your business operations without proof of negligence.

Care, Custody, and Control Property Damage Liability Coverage—Provides up to \$10,000 per occurrence/\$30,000 per policy period property damage coverage for unintentional damage to property of others in your possession taking place away from your premises and resulting from your business operations which you become legally obligated to pay.

Liability Coverage for Damage to Electronic Data—Provides up to \$10,000 property damage coverage for loss of electronic data of others which you become legally obligated to pay.

Medical Payments Coverage—Increases your medical expense coverage limit to \$10,000.

Automatic Additional Insured - Lessor of Leased Equipment—Automatically adds under your policy a person or organization from whom you lease equipment as an additional insured when agreed upon between you and that person or organization in a written contract to add that person or organization as an additional insured with respect to liability for bodily injury or property damage arising solely out of the maintenance, operation, or use of leased equipment by you which may be imputed from you to that entity.

Automatic Additional Insured - Managers or Lessors of Premises—Automatically adds under your policy a person or organization from whom you lease a premises as an additional insured when agreed upon between you and that person or organization in a written contract to add that person or organization as an additional insured with respect to liability for bodily injury or property damage arising solely out of the ownership, maintenance, or use of that part of the premises leased to you.

Enhancement Endorsement

Property Damage Liability Coverage for Borrowed Equipment While Off Premises—Provides up to \$10,000 per occurrence/\$30,000 per policy period property damage coverage for unintentional damage to borrowed equipment in your possession taking place away from your premises and resulting from your business operations which you become legally obligated to pay.

Automatic General Aggregate Limit Per Construction Project—Automatically amends the General Aggregate Limit under your policy to provide a Construction Project General Aggregate Limit of Insurance for a person or organization that you are performing operations for, if you and that person or organization agree in a written contract to provide a Construction Project General Aggregate Limit of Insurance for that person or organization you are performing operations for.

Automatic Additional Insured - State or Political Subdivision—Automatically adds any state or governmental agency as an additional insured if you and the state or governmental agency have agreed in a written agreement or contract to add the state or governmental agency as an additional insured under your policy with regards to liability for bodily injury or property damage arising solely from hazards defined in the endorsement for which a state or governmental agency has issued a permit in connection with your premises.
